ELIGIBILITY AND CRITERIA

This award shall be given to one College of Health and Human Development rising senior.
Applicants must not be graduating before December 2009.

Candidates must:

1. have at least sixth semester standing at the beginning of Spring Semester 2009;
2. demonstrate outstanding scholarship (3.0 or above cumulative grade-point average), and;
3. demonstrate outstanding leadership in the College and at Penn State.

NOMINATING PROCEDURE

The Director of Alumni and College Relations will receive the nominations and forward them to the Awards Committee of the HHD Alumni Society. Nominations may be made by students, faculty, staff, and alumni until February 6, 2009. Students may nominate themselves.

The nomination/self-nomination shall consist of:

1. Completed application form (attached).
2. Statement by the candidate, in 12-point font, with one-inch margins, not to exceed one page, explaining why he/she should be considered.
3. One letter of reference from a faculty member of the College.

SELECTION COMMITTEE

The recipient of this award shall be selected by the Awards Committee of the College of Health and Human Development Alumni Society.

THE AWARD

The recipient shall receive a \$1,000 scholarship that will be applied toward tuition during the next academic year. The recipient will also be honored at a ceremony on March 27, 2009.
