COURSE TITLE: Medications and the Elderly Client

CREDIT HOURS: 1 SH (1,0)

CATALOG DESCRIPTION:

Nursing implications of the medication therapy with the elderly client.

Prerequisites: None

COURSE OBJECTIVES:

Upon completion of this course, the student will be able to:

1. Discuss factors which influence drug use and misuse by the elderly client.
2. Identify drugs commonly used and misused by the elderly client.
3. List age-related changes which influence drug actions in the elderly and place the elderly client at risk for adverse reactions.
4. Identify appropriate assessment criteria for evaluating and monitoring medication therapy in the elderly client.
5. Describe nursing interventions which promote safe medication therapy in the elderly client.

TOPICAL OUTLINE:

- I. Introduction and overview of aging population.
- II. Age-related changes affecting drug actions and uses.
- III. Drugs commonly used by the elderly client.
- IV. Risk factors related to pathology, attitudes, and lack of information.
- V. Drugs commonly misused by the elderly.
- VI. Nursing assessment of drug use in the elderly.
- VII. Nursing interventions in medication management.

Lecture, Discussion, Case Studies, Critique of Article, Medication Assessment

Academic integrity is the pursuit of scholarly activity free from fraud and deceptions and is an educational objective of this institution.  - a. Requests for taking exams or submitting assignments after the due dates require documentation of events such as illness, family emergency or a university sanctioned activity.
 - b. Conflicts with dates on which examinations or assignments are scheduled must be discussed with the instructor or TA prior to the date of the examination or assignment.
